The Chamber of Commerce is a non-profit organization, independent of government. The Humboldt & District Chamber of Commerce (HDCC) has been doing work in Humboldt for 107 years. Membership has grown over 70% in the past few years with the Chamber reaching 264 members in 2014. While once an organization that focused on the City of Humboldt, we are now reaching out to the entire region and encompass businesses within a 50+km radius of Humboldt. We have 2 full time employees to serve your needs.

### Why Join?

Along with these initiatives, we continue to meet with investors interested in our region, work with City Council to address business issues, host Chamber Business luncheons and business after business networking events, attend community and business events, work with members to address issues and do our part to promote the region as a whole.

The HDCC has 3 committees – Tourist Booth & Campground, Public Relations & Promotions, and Business Retention & Expansion. Each Director volunteers to be a part of one or more of these committees which meet regularly through the year to discuss projects and initiatives to better help our members.

### **Committee Reports:**

#### **Tourist Booth & Campground – Chair Kevin Plemel**

The Tourist Booth and Campground Committee is a valued piece of what enables our Chamber to be financially viable. The revenue that it produces allows us to hire summer students and to bring tourists to Humboldt and area during the spring, summer, and early autumn. While we had our challenges, throughout 2014, it will only serve to better prepare us for the winds of change that the 2015 tourism season brings. The Tourist Booth and Campground would like to thank all partners who help it be a successful endeavor for the Humboldt and District Chamber of Commerce. The development of a walking trail and bench between the campground and the Humboldt Golf Course is a great achievement for the community and we'd just like to take this

opportunity to thank the Humboldt and District Trails Committee. As well, the City of Humboldt deserves many thanks for supplying us with a continued contract to be the managers of this property and for the Visitor Information Services component. All of the other partners, suppliers, and contributors who assist with making the Tourist Booth and Campground continue to operate also deserve our many thanks.

During 2014, the Tourist Booth and Campground Committee saw income decline from the previous 5 year uptrend in growth. The actual income was 40% lower than the previous year and was close to that of 2009. The mini golf revenue was also lower with a 20% drop. The committee mainly attributes the lowered income to our money collection processes that were not followed as in years prior. In response to the declines in revenue, this committee began looking at the opportunities and potential lost revenue rationale within the Tourist Booth and Campground.

At the conclusion of the 2014 camping season, our Executive Director and this committee had begun working on new written policies and procedures for the betterment of the staff who will be working in the campground office, going forward and for preventing the same occurrence of unrealized revenue, next season. Some highlights of new policies and procedures are: checklists for summer staff, camper contracts, and credit card pre-authorizations. Items of concern such as cash being kept at the Tourist Booth and damage occurring to campsites are planned for within our new written procedures. Also of note, camping rates will be \$3.00 higher for both non-electrical and electrical sites for 2015.

In closing, thank you to the committee members, the Executive Director, and the Administrative Assistant for their hard work in adapting to their changing roles and for preparing us going forward. It was not made any easier for the simple fact that both the Executive Director and Administrative Assistant had to start fresh in their jobs, save for the other fact that we also moved them away from the campground into a new office, located in downtown Humboldt. Best wishes to those who form the new committee that will be leading the way during 2015.

### **Public Relations & Promotions – Chair Mike Yager**

As always, the PR&P Committee had a very busy year, filled with lots of promotions, public events, business gatherings and celebrations. A committee of six board members provided guidance and assistance to ensure our events were successfully planned and executed. Thank you to Jodi Smith, Stacey Leroux, Andre Kruger, Dan Torwalt, and Ivan Yackel for your participation and commitment. Special recognition goes out to Deb and Colleen for their dedication to making each event a success, even through all the challenges of planning each promotion for the first time. ### **Business Retention & Expansion – Chair Joanne Forer**

The Business Retention & Expansion Committee is responsible for communication with municipal government, growth opportunities & challenges, service gaps, health & education and membership recruitment & retention. This year, we met with City Council as a board to discuss opportunities and challenges and in 2015 this meeting will occur twice in the year. We continue with doctor recruitment and retention and toured potential new doctors through the area. Our partnership with Junior Achievement of Saskatchewan remains strong; they offer innovative programs that stimulate and inspire elementary, middle and high school students to value free enterprise, understand business and economics, and develop entrepreneurial and leadership skills. This partnership will go a long way as it helps prepare our future workforce.

We ventured into a new area this year to strengthen regional partnerships by attending all of the RM, Town and Village Council Meetings within a 50km radius. Our goal is to have a regional meeting with all of them this fall. Another new achievement is that BHP Billiton has agreed to fund furniture for our boardroom; the boardroom will be available to rent to businesses and community groups in late spring.

Our region saw many new small businesses opening and we assisted 5 new businesses with their Grand Opening. Memberships also continue to grow. We ended 2014 with 264 members, as compared to 247 in 2013. A breakdown of members by categories is as follows:
