Membership has grown over 70% in the past few years with the Chamber reaching 260 members in 2015. While once an organization that focused on the City of Humboldt, we are now reaching out to the entire region and encompass businesses within a 50+km radius of Humboldt. We have 2 full time employees to serve your needs.

## **Tourist Booth & Campground – Chair Kim Mitchell**

The Visitor Information Centre and Campground committee is an important financial piece to the Humboldt & District Chamber of Commerce. This year the committee was made up of Brian, Andre and myself. I would like to give a big thank you to the committee Colleen, Stewart and the campground staff for all their hard work in making 2016 season a success. Under Colleen's watchful eye the campgrounds increased revenue 33% over last year.

After the 2015 season, we decided, due to financial reasons, to have our Office Manager, Colleen, run the Campground and Visitor Information Centre for the 2016 season. The campground needed some TLC so we began the season increasing the sizes of some of our camp sites and taking out the brush and trees. This was to improve the campground aesthetics as well as safety. Over the last year we have made a very long list of things that need to be improved and a maintenance plan is in the works. We are looking at grants to revamp the mini golf as we lost 2% in income over the last year and it is in need of some major repair. We are also looking at new storage options and getting some new maintenance equipment.

As many of you may know we have made the exciting announcement that we are moving back to the Visitor Information Centre and Campground permanently. We will be taking two weeks in April to move the office and will be up and running for May 1. We are currently working on the renovations to make the space work for us as well as working with the city to explore the possibility of expanding the building. This move will be great for the Chamber as well as the City of Humboldt. We are looking forward to see what the 2017 season will bring.

## **Conclusion**

Our success and effectiveness is directly related to our membership base and therefore we appreciate and value your membership with the Chamber and encourage you to communicate with us on a regular basis.
